PEFINDO affirms "idA" rating to PT Indomobil Finance Indonesia's maturing Bond

PEFINDO has affirmed its "idA" rating for PT Indomobil Finance Indonesia (Indomobil Finance)'s maturing Shelf Registration Bond III Phase II/2018 Series B of IDR240.0 billion which will mature on February 15, 2021. The Company's readiness to repay its maturing bond is supported by its cash and cash equivalent of IDR920.8 billion, average monthly collection receivables of IDR538.8 billion and unused credit facility of IDR3.3 trillion as of September 30, 2020.

A debt security rated idA indicates that the obligor's capacity to meet its long-term financial commitments on the debt security, relative to other Indonesian obligors, is strong, however, the debt security is somewhat more susceptible to the adverse effects of changes in circumstances and economic conditions than higher-rated debt.

Indomobil Finance is the financing arm of the Indomobil Group, a leading automotive group in Indonesia that holds distribution licenses for a number of global car manufacturers. The Group is also involved in other automotive-related businesses, including after sales service, vehicle assembly, component manufacturing, and spare parts distribution. As of September 30, 2020, it was fully owned by the Indomobil Group through PT Indomobil Multi Jasa Tbk (99.909%) and PT IMG Sejahtera Langgeng (0.091%).
