PT Barata Indonesia (Persero) rated "*idD*"

PEFINDO has assigned the rating of PT Barata Indonesia (Persero) (Barata) to "*idD*" from previously "*idSD*" and lowered the rating of its Medium-Term Notes (MTN) I Year 2017 Series A to "*idD*" from "*idCCC*". The rating actions reflects Barata's status in temporary postponement of debt payment obligations (PKPU) by the court until October 5, 2021. Under temporary PKPU, Barata is trying to restructure all of its debts, including MTN, bank loans, as well as its suppliers' payables. We view Barata's liquidity as vulnerable following its somewhat weak operating management that lead to negative profit margin and limited financial flexibility.

An obligor rated *idD* has failed to pay all of its financial obligations, rated or unrated, when they came due.

PT Barata Indonesia (Persero) is a state foundry and manufacturing company, the shares of which were 100% owned by the Government as of June 30, 2021. It manufactures iron and steel castings and forged components for sale to industrial and energy companies. As a midstream player, its industrial castings are engineered and produced for applications to be used in a range of industry sectors, such as agro, oil and gas, rolling stock, hydro mechanical, industry process, as well as construction and material handling equipment. Barata also positions itself as an engineering, procurement, and construction (EPC) company, leveraging its long experience in foundry and manufacturing for greater job acquisitions, with focus on sugar and agro, oil and gas, generator, water resources, and component machinery.
