PEFINDO affirms “*idA+*” rating for maturing bond of PT Indah Kiat Pulp and Paper Tbk

PEFINDO has affirmed its “*idA+*” rating for PT Indah Kiat Pulp and Paper Tbk (INKP)’s Shelf Registered Bond I Phase II/2020 Seri A of IDR926.5 billion that will mature on September 26, 2021. INKP will repay the maturing bond using its internal cash. As of March 31, 2021, it had cash balance of USD772.2 million or equivalent to about IDR11.2 trillion.

An obligor rated *idA* has a strong capacity to meet its long-term financial commitments relative to that of other Indonesian obligors. However, the obligor is somewhat more susceptible to the adverse effects of changes in circumstances and economic conditions than higher-rated obligors. The Plus (+) sign indicates that the rating is relatively strong within the respective rating category.

INKP is the leading pulp and paper manufacturer, not just in Indonesia but across the world. Operating since 1976, it produces pulp, cultural and industrial paper, packaging, and tissue products. It has mills in Tangerang and Serang in West Java, and in Perawang, Riau, in Sumatra. As of March 31, 2021, it was majority owned by PT Purinusa Ekapersada (53.25% ownership), part of the Sinarmas group of companies. The remaining shares were held by the public (46.75%).
